Background

The SABPP has been without a permanent home for many years and utilised the rental option. It has always been our aspiration to acquire our own property for many reasons including but not limited to;

- Equity Build-Up
- Control and Customisation
- Stable and Predictable Costs
- Long Term Planning
- Asset Appreciation and Liquidity: Real estate has the potential to appreciate in value over time, providing the SABPP the opportunity for return on investment when the property is eventually sold (should there be a strategic need to do so).

The Board approved the proposal to search for an alternate home for SABPP in March 2023 considering the fact that our five-year lease with Growthpoint was coming to an end within 10 months.

Various options were considered including possible lease renewal, finding another affordable rent property and buying our own space. Considering all the options presented by the task team under the project name "Reavaya" the Board opted to outright purchase a plot-based office following a thorough review of costs and benefits.

This would be like an SABPP Campus allowing us to use as a multi-centre for the office, academy, conferencing, research centre and more. The Board took advice and guidance from staff, the task team appointed by the Board as well as the Risk and Audit committee with our Accountants.

The Board decision considered, inter alia.

- Immediate and future needs
- Self sufficiency
- Multipurpose
- Accessibility
- Brand promotion
- Affordability
- Training and conference rooms
- Maintenance
- Staff convenience
- Safety and security

Dr James Ramakau the Board chair asserted that 'it is important to note that owning an office space also comes with potential risks, such as the responsibility of property maintenance, repair costs, and the financial risk associated with property ownership such as insurance and security. Moreover, the trend of remote work was also taken into account to reaching this big purchase decision. I can assure you that the decision to own or to rent office space was carefully considered based on factors such as SABPP financial position, growth projections, and long-term strategic plans to investing into our profession.'
